

Solicit bids from the sublet work only to responsible, licensed, insured (workman's compensation and public liability) and qualified sub-contractors giving each equal opportunity and holding all such bids in strictest confidence prior to bid opening.

Transact my business in such a manner that I may give service commensurate with the highest standards of the construction industry.

Conduct my affairs in such a manner as to inspire in others concerned with the construction industry a full appreciation of the intent and meaning of this Code of Ethics, and a realization the value of membership in an organization, which recognizes and supports such a code.
